# LEGAL SERVICES (FEES) REGULATIONS, 2025

(SL 44 of 2025)

In exercise of the powers conferred by section 99 of the Legal Services Act, 2020, the Cabinet makes the following Regulations —

#### Citation and commencement

- 1. (1) These Regulations may be cited as the Legal Services (Fees) Regulations, 2025.
  - (2) These Regulations come into force on 1st January, 2026.

#### Practising certificate fees

2. The practising certificate fee under section 49(2) of the Act shall be as specified in Schedule 1.

#### **Annual operational licence fees**

**3**. The annual operational licence fee under section 64(3) of the Act shall be as specified in Schedule 2.

**4**. The fees payable in respect of each item listed in the second column of the table in Schedule 3 shall be as specified in the third column of the table.
